After much thought and consideration, I am writing to inform you that I will be retiring from the Winnemucca, NV practice of dentistry. Dr. Rick L. Grant, DMD will be **closing the clinic permanently effective July 28th, 2026.**

If you are currently undergoing treatment, please arrange for follow-up care with another dentist to avoid any interruption in your dental health needs.

Your dental records will remain confidential and will be maintained in accordance with applicable federal and state laws.

Patients may obtain a copy of their dental records or request that records be transferred to another dental provider by submitting a **written** authorization.

Payment for outstanding balances can be mailed to the address provided above. If you are paying by credit card, please call the office and receipts can be emailed to you.

Again, thank you for allowing me the privilege of serving you and your family since 1995. The relationships formed over the years have been one of the greatest blessings of my professional career. While I am retiring from my Winnemucca, NV practice, I will always cherish the memories, friendships, and trust that this community has shared with me.
